Proposed Change in Meeting Day and Venue

A proposal was introduced at the September meeting that, if passed, will change the day of the monthly meeting from the first Saturday to the third Thursday of each month. In addition, because of changes, which were implemented at the VFW hall beginning in mid-September, the room used by both the VFW and the Marine Corps League for their meetings will become a dedicated gaming room.

The reason for the day change is that many of our members who do not participate cite the fact that they have familial and other obligations on most weekends that prevent them from attending the meetings. We support many programs, in principle, but are limited in what we can do because of the low turnout. Although the newsletter helps inform our membership, it is not a substitute for attendance.

Also, the new use of the space, necessitated by efforts to reverse the financial crunch experienced by the VFW with the loss of Bingo revenue, prompted the suggestion that we move our meetings to the Disabled American Veterans hall on the corner of East Austin and Appleby-Sand Road. The move will require that we pay for the hall, the cost of which is a modest \$20 per month to cover the utilities.

There will be another reading of the proposals before they are voted upon. Members are urged to attend the October meeting to voice their preference.

CHANGING MILITARY RECORDS

If you feel there is an error or an injustice in your military personnel records you can apply to your service's Board for the Correction of Military Records whether you are active duty, separated, or retired. Any person with military records, or his or her heirs or legal representative, may apply to the appropriate service's Board. The Army, Air Force, and Coast Guard have separate boards. The Navy operates the Board for both Navy personnel and members of the United States Marine Corps.

Title 10, United States Code, Section 1552, is the law governing correction of military records. This statute authorizes the Secretary of the service concerned to correct any military record when "necessary to correct an error or injustice." The purpose of this statute was to relieve the Congress from consideration of private bills to correct errors or injustices in military records. The statute provides for the service secretaries to act through a board of appointed civilians in considering applications for correction of military records. Implementing regulations for each service are:

- AFI 36-2603, Air Force Board for Correction of Military Records, implements the statute within the Air Force;
- Army Regulation 15-185 implements the statute within the Army;
- The Code of Federal Regulations; Title 33, Part 52;2. implements the statute within the Coast Guard;
- The Navy and Marine Corps implements the statute through The Navy;
- Code of Federal Regulations; Title 32, Part 723.

PURPLE HEART HALL OF HONOR: The National Purple Heart Hall of Honor is conducting a nationwide effort to register Purple Heart recipients in the museum's database. So far, 70,000 recipients have been registered since the Hall of Honor opened in New Windsor, NY in November, but organizers hope to enroll as many as 1.5 million, said Sergio Morales, a member of the museum's board of directors. Hall visitors can access the list of Purple Heart recipients on the museum's 15 computers that chronicle photos and stories about those who have earned the medal. The Defense Department does not keep an official database of Purple Heart recipients. Hall of Honor organizers hope their efforts will create as complete a list as possible of those who have earned the medal to ensure they are not forgotten, Morales said. To register with the Hall of Honor, recipients must prove they received the medal by submitting the appropriate official documentation, including a DD-214, DD-215, WD AGO-53-55, General Orders or a Letter of Transmittal. Hall officials also requested recipients send a written narrative of how they earned their medal, any newspaper articles written about them receiving the medal, and any photographs of them while in the service. Although it's not required, recipients can also tape an interview at the Hall of Honor chronicling their service and the events that led to their Purple Heart. An unedited copy of the DVD is given to the recipient, while an edited version is kept at the Hall and stored with that individual's record. Marine Corps History

5 October 1775: Meeting in Philadelphia, Pennsylvania, the 2d Continental Congress used the word "Marines" on one of the earliest known occasions, when it directed General George Washington to secure two vessels on "Continental risque and pay", and to give orders for the "proper encouragement to the Marines and seamen" to serve on the two armed ships.

9 October 1917: The 8th Marines was activated at Quantico, Virginia. Although the regiment would not see combat in Europe during World War I, the officers and enlisted men of the 8th Marines participated in operations against dissidents in Haiti for over five years during the 1920s. During World War II, the regiment was assigned to the 2d Marine Division and participated in combat operations on Guadalcanal, Tarawa, Saipan, Tinian, and Okinawa, and earned three Presidential Unit Citations.

11 October 1951: A Marine battalion was flown by transport helicopters to a frontline combat position for the first time, when HMR-161 lifted the 3d Battalion, 7th Marines, and its equipment, during Operation Bumblebee, northeast of Yanggu, Korea.

You should exhaust other administrative remedies before appealing to your service's board. For example, you should first submit a performance report appeal to the appropriate appeal agency before appealing to your service's military records correction board.. An appeal requesting upgrade of discharge should normally be submitted to the service's Discharge Review Board under Department of Defense Directive (DoDD) 1332.28, Discharge Review Board (DRB) Procedures and Standards. The board will return your application if you have not first sought relief through the appropriate administrative process. You should submit your request within 3 years after you discover, or reasonably could have discovered, the error or injustice. The boards review the merits of untimely applications. If found to be meritorious, the timeliness is waived in the interest of justice. You should not assume, however, that a waiver will be granted.
